



# Vendors with Active Referral Moratoriums as of 11/15/2018

Per Title 17, Section §56057, The Regional Center of Orange County typically applies sanctions to a facility when there are two findings of substantial inadequacy within a twelve-month period. As the “placement” or “referral” agency, these sanctions are in the form of a moratorium of new referrals or “placements” for a specified time frame and/or until the substantial inadequacy has been corrected. Please note the Regional Center of Orange County applies residential sanction regulations to all vendors. The vendors listed below have been placed on a moratorium from receiving new referrals for the specified dates.
