The 5<sup>th</sup> session on August 5<sup>th</sup> will focus on toilet training. Participants interested in the toilet training are encouraged to attend the first 4 sessions.

Dr. Sweitzer is a licensed psychologist and Board Certified Behavior Analyst, specializing in Applied Behavioral Analysis and developmental disabilities. Dr. Sweitzer received her Doctorate degree in Education Psychology from the University of Southern California and has over 30 years of experience working with individuals with challenging behaviors in a wide range of settings including home, school, residential settings and vocational day programs. She has conducted numerous workshops and presentations on Applied Behavior Analysis nationwide. During her extensive career, Dr. Sweitzer has held clinical and management positions at the Florida Mental Health Institute's Parent and Child Training project, the Regional Center of Orange County, and private treatment agencies. In 1990, Dr. Sweitzer started a behavior consulting practice in Southern California that supports children and adults with developmental disabilities. In 2005, she founded Behavioral Support Partnership, providing in-home treatment services for children with developmental disabilities and their families, where she currently serves as President and Executive Director.

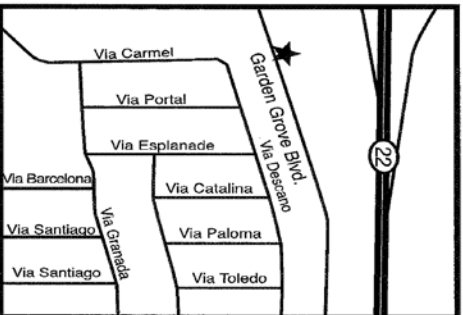

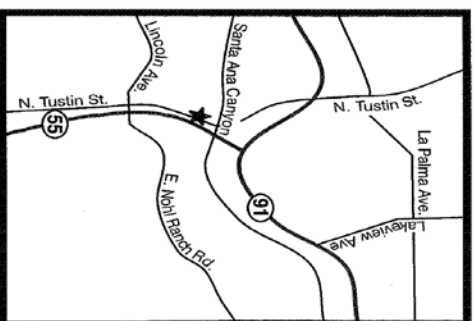
