Federal News


Stimulus package just passed

- \$286 billion in *direct economic relief for workers and families*
- \$325 billion for small businesses
- \$69 billion is provided for COVID-19 vaccines, testing and tracing, community health and heath care provider support
- Funding is also made available for schools, broadband, rental assistance, nutrition and agriculture, childcare transportation
- The package also repurposes \$429 billion in unused Cares Act funds for emergency lending programs run by the Federal Reserve

Federal News continued

- The Centers for Medicare & Medicaid Services (CMS) has issued an Interim Final Rule with Comment (IFC) that reflects changes in the agency's interpretation of the Maintenance of Effort (MOE) provisions related to the 6.2% enhanced FMAP included in the Families First Coronavirus Relief Act (FFCRA)
- One requirement in the FFCRA MOE is that states must maintain the enrollment and coverage of Medicaid beneficiaries who were enrolled as of or after March 18, 2020
- The rule reminds states that one requirement for receiving the 6.2% FMAP increase is to "cover, without the imposition of cost sharing, testing services and treatments for COVID-19, including vaccines, specialized equipment, and therapies"



Intake and Outreach During the Pandemic

Board of Directors' Meeting January 14, 2021

Eligibility

- ♦ Early Start (0-3 years of age)
 - Infants and toddlers with developmental delay(s), established risk or at-risk
 - ◆Eligible until 3rd birthday
- Lanterman
 - ◆Individuals with an eligible condition (ID, CP, Epilepsy, Autism) that is substantially disabling and likely to continue indefinitely

Early Start Eligibility

- Early Start eligibility is short-term, agelimited
 - Includes a variety of services: speech, occupational therapy, physical therapy, infant stimulation, and behavior therapy
- ♦ 85% of Early Start children exit regional center services (i.e., not Lanterman eligible at age 3)
 - At age 3, those eligible for school district services transition to education supports
 - Those not eligible for school district services are referred to community resources

Early Start & Lanterman Referral Sources

- Pediatricians/physicians
- Neonatal Intensive Care Units (NICUs)
- Families/self-referral
- Community partners, including Help Me Grow, First 5, California Home Visitation Programs, Family Support Network
- ♦ Schools
- Other community partners, including Orange County Mental Health, California's Department of Rehabilitation

Decline in Referrals

- The number of new referrals for assessment started to decline when Governor Newsom declared the State of Emergency in March
- ◆ During the pandemic, compared to the prior 12 months, Early Start and Lanterman referrals decreased ~40%

Impact of COVID-19

- Generalized fear, anxiety and apprehension
- Pre-schools, schools and businesses, were closed, families at home, fewer professional eyes on children
- Less access (fewer doctors' appointments available)
- Longer appointment times (more exposure)
- Family distress
 - Balancing priorities
 - Some lost jobs
 - Loss of social supports

- Outreach to school districts
- Facilitating access
 - ◆Enhanced customer service



Future of Early Start Referrals

- Decline in Early Start and Lanterman referrals are approximately the same, both will come back
- Going forward, we may see lower growth
- U.S. birthrate declined following the Great Recession of 2007-09
- ♦ Lower birth rate U.S. births in 2019 lowest recorded since 1985 (down 1% from 2018) Source: Center for Disease Control
